

**Board of Education
Official Proceedings
Regular Board Meeting
February 13, 2017**

CALL TO ORDER

President Zanotti called the Regular Board Meeting of the Bay City Public Schools Board of Education to order on Monday, February 13, 2017, at 7:18 p.m., in the Cafeteria at Handy Middle School, 601 Blend Street, Bay City, MI.

PLEDGE OF ALLEGIANCE

Communications and Marketing Committee: Trustee Rademacher shared that the first Organizational meeting has been set for February 23, 2017 and he is pleased with the representation of staff members who have agreed to serve on the Committee.

Board Member Building Visits:

- Trustee Helmling shared that she visited Hampton Elementary and really enjoyed the students' comments. Hampton is a Title I school with nearly 60% Free and Reduced, which many people may not be aware of.
- Trustee Jeske shared that she visited both Western Middle School and Western High School and the kids were fabulous. She also visited MacGregor Elementary and found it to be a nice, calm, great place to be.

REGULAR AGENDA

MASB BOARD OF DIRECTORS ELECTION FOR REGION

The board was asked to come to a consensus for submitting a ballot for our Region IV Director.

Trustee Baird made the motion, supported by Trustee Rademacher, to submit a ballot in support of the incumbent, Matthew Showalter. Yeas: Trustees Baird, Bauer, Rademacher and President Zanotti. Nays: Trustees Helmling and Sepeda. Abstained: Trustee Jeske. The motion passed 4-2.

RECONSIDERATION OF THE COOPERATIVE RECREATIONAL AGREEMENT FOR DEVELOPMENT OF THE THOMAS JEFFERSON PROPERTY (WITH THE CITY)

The Board reconsidered an agreement with the City of Bay City, a Cooperative Recreational Agreement for the Development of the Thomas Jefferson Property. The City decided to reverse their intent to provide \$25,000 for the development of tennis courts at the former Thomas Jefferson School property. The Board had approved the agreement at the October 10, 2016 Board Meeting, however the City never executed the Agreement. The Board voted to direct the Board Attorney, Mr. Allsopp, to withdraw the District's offer of agreement with the City related to the Thomas Jefferson property development.

Trustee Baird made the motion, supported by Trustee Bauer, to direct the Board Attorney to withdraw the District's offer of agreement with the City related to the Thomas Jefferson property. Approved unanimously.

PROVIDE DIRECTION RELATED TO ADDITIONAL INFORMATION FOR A SINKING FUND

The Board was asked to consider what direction they would like to provide related to obtaining more information on the possibility of a Sinking Fund Millage

Trustee Helmling made the motion, supported by Trustee Jeske, to direct the Superintendent and Director of Finance to gather additional information related to the possibility of a Sinking Fund Millage. Approved unanimously.

PERSONNEL CHANGES

This item was moved from the Consent Agenda to the Regular Agenda.

The Board of Education was asked to approve changes in personnel for the month of January 2017 but also to add a column in future reports that indicates the sources of funding for the positions.

Trustee Rademacher made the motion, supported by Trustee Sepeda, to approve Personnel Changes for the month of January as well as adding an additional column in the report to show funding sources. Approved unanimously.

NEW BUSINESS

The Board discussed pursuing additional information related to the options and associated costs in order to reoccupy the north end of the Administration Building.

Trustee Baird made the motion, supported by Trustee Rademacher, to direct the Superintendent and the Director of Facilities to research options and costs associated related to reoccupying the north end of the Administration Building. Approved unanimously.

Also under New Business, President Zanotti asked Trustees Helmling and Sepeda to review the previous superintendent evaluation tool as well as the new MASB evaluation tool to merge the two documents for this year's superintendent evaluation process.

EXECUTIVE SESSION

Trustee Jeske made the motion, supported by Trustee Bauer, to move into Executive Session for the purpose of receiving an update on negotiations and discuss setting the

March 2017 School Calendar, as permitted under Section 8 (c) of the Open Meetings Act as well as for the purpose of discussion on the status of Worker Comp Case #W150018745, as permitted under Section 8 (e) of the Open Meetings Act. Approved unanimously.

The Board moved into Executive Session at 8:45 p.m. and came out of Executive Session at 10:42 p.m.

MARCH 2017 CALENDAR

Trustee Helmling made the motion, supported by Trustee Sepeda, to approve the recommendation of Administration to set the March 2017 School Calendar as presented in a memo dated February 14, 2017. The school calendar is a negotiable item and the 2016-17 calendar has not been finalized. Approved unanimously. (Attachment B).
